



RISK REDUCTION STRATEGIES

Anesthesia Risk Strategies:

- Initiate preoperative obstructive sleep apnea (OSA) screening protocol (i.e. STOP, etc.) to identify at-risk patients.
- Communicate preoperative findings, including complete review of the patient's history, medical record and OSA screening results with the anesthesia member responsible for induction.
- Execute an anesthesia informed consent form written in layman's terms.
- Discuss the anesthesia plan and actively participate in team time-out with the OR team.
- Remain in the OR while patient is receiving anesthesia.

Additional Risk Reduction Strategies:


- Anesthesia team remains in-house while patient recovers in PACU.
- Documentation is timely, concise and accurate.
- Verify and document initial intubation placement and re-verify after patient transfer.
