

# **Improving Maternal Health**

### Question

According to data compiled from maternal mortality review committees (MMRCs), more than 80 percent of pregnancy-related deaths in the United States are preventable. What are some recommendations for healthcare organizations to reduce the number of pregnancy-related deaths and improve maternal health?

#### **Answer**

Maternal morbidity and mortality are serious concerns in the United States. To better address these concerns, healthcare organizations and providers can implement the following strategies:

Build connections between birthing professionals and healthcare organizations. All
parties in the birthing process should be encouraged to communicate. Open communication
helps everyone feel respected and part of the team. The goal is to create the best birthing
experience possible, and collaborating as a team will foster this goal.

Actively participate in the collection of meaningful morbidity and mortality data (including "near misses") and the development of evidence-based solutions.

Participation in MMRCs supports the collection of valuable data to promote maternal health. These committees, which meet at the state or local level to review deaths during or within 1 year of pregnancy, seek to understand the circumstances surrounding each death so they can devise recommendations for action to prevent deaths in the future. - Use a health equity framework. Develop measures to support health equity work, including
  collecting race, ethnicity, and language (REAL) data. To develop and maintain a health equity
  framework, see guidance in the Institute for Healthcare Improvement's white paper on
  Achieving Health Equity: A Guide for Health Care Organizations.
- Have a system in place to identify families in need of additional resources and support.
   Collect and trend data to identify patients/families who may need help due to homelessness,
   lack of nutritional food, and other factors affecting their health and well-being. Collecting data
   can help support the case to strengthen the public health infrastructure.
